



## How Can California Educators Best Support the Needs of Students With Dyslexia?

Dyslexia is generally defined as a disorder that involves difficulty in learning to read but does not affect general intelligence. According to the International Dyslexia Association<sup>®</sup>, **dyslexia may affect as much as 15% to 20% of the population**—making it a central educational issue for California educators.

## Senate Bill 114 Mandates Dyslexia Screening in California

**The Education Omnibus Budget Trailer Bill (SB 114) will require California schools to implement universal K–2 screening for reading delays, including the risk of dyslexia.** The bill requires the State Board of Education to develop evaluation criteria and designate an expert panel to approve a list of appropriate screening instruments. Local education agencies (LEAs) will need to select screeners from the approved list and begin annual screening by the 2025–2026 school year.

The bill states that screening is one of many tools educators can employ to gain information about how to support their pupils' learning. Additionally, **early identification and intervention with evidence-based early literacy instructional strategies and materials improves literacy outcomes.**
