
Lexia® English Language Development[™] Connecticut English Language Proficiency Standards

Lexia English addresses the Connecticut English Language Proficiency Standards with a primary focus on speaking and listening, aiming to drive Emergent Bilingual students' language proficiency and long-term academic success.

This document illustrates how Lexia English fully aligns with the Connecticut English Language Proficiency Standards for Kindergarten through grade 6 across the five proficiency levels, Levels 1–5. Although there are many examples of alignments to the standards, the last column provides two sample alignments per standard.
